

#### 使用说明

步骤 1: 打开前面的两个腰带,像背包一样双手穿过肩 带。背板的中心与脊柱对齐,底部大约位于骶尾联合处。 用力将勾面腰带固定在毛面腰带上,使得腰部固定器与 身体紧密贴合(图 1a)。

步骤 2: 调整肩带。取下肩带尾端的魔术贴,将肩带和

肩衬垫调整到舒适的位置, 使得肩带和衬垫与身体贴合。 如果肩带过长,可将肩带剪裁到需要的长度,再将取下的 魔术贴头装上并固定在肩带上即可(图 2b)。

步骤 3: 在检查好穿戴位置正确和穿戴舒适后,将腰带两 边的拉环往外拉使得固定器收紧贴合身体后再粘附在腰 带的毛面上(图 3a~3d)

The product is mainly composed of air-permeable mesh cloth, nylon wire, pull ring, liner, plastic pulley support system and magic

5)Operating principle:

The product adopts double independent mechanical pulley system, which provides patients with superior compression level, maximum comfort, flexible control system, stable support and effective pain relief. Flexible rear pulley system, in line with the patient's body type, standing or sitting can easily adjust the required comfort. Soft cushions provide comfortable wear for patients.

6) Scope of application:

It is suitable for lumbar discectomy / fusion surgery with low back pain / strain lumbar disc injury, compression fracture, osteoporosis, disc herniation and degenerative lumbar spondylolisthesis.



#### **APPLICATION INSTRUCTIONS**

**STEP 1:** Open the two belts in front and put your hands through the straps like a backpack. The center of the dorsal plate is aligned with the spine, and the bottom is about the sacra joint. The hook belt is fastened to the hairy belt so that the waist retainer fits closely with the body (Fig. 1a).

**STEP 2:** Adjust the shoulder strap. Remove the magic sticker at the end of the shoulder strap and adjust the shoulder strap and shoulder pad to a comfortable position to fit the shoulder strap and pad to the body. If the straps are too long, cut the straps to the desired length, and then install the removed magic stickers and fasten them to the straps (Fig.2b).

**STEP 3:** After the proper and comfortable wearing position is checked, pull the pull rings on both sides of the wide belt to pull out, so that the fixer is tightened and attached to the body and then adhered to the surface of the wide belt (Fig. 3c~3d).

#### \*CAUTION:

- 1. The above steps should be used by qualified professionals. Any further adjustment or wear frequency and wear time will be determined by your orthopedic professional.
- 2. Don't tighten the pressure system too much to avoid discomfort or dyspnea. When sitting down, the patient may need to loosen the pressure system a little.

#### **Maintenance:**

Soft items can be washed with neutral detergents and 30 °C sailors and dried naturally. Do not put in the clothes dryer or use other heat sources for drying. Salt water, sand, dirt and other elements can cause damage. After exposure to these conditions, rinse thoroughly with clean water and dry or dry towels (not machine dry). If you need detergent, please use mild detergent; do not use softener and bleach. Rigid parts can be wiped clean with wet cloth.
