用于跟腱炎,急性和慢性足底筋膜炎疼痛,脚后跟刺痛脚跟骨刺和发炎患者的辅助治疗。



步骤1:解开绑带 #1,绑带 朝上将脚放入固定器里面 (图 a)

步骤 2: 调整固定器的踝气囊 #2 和 #3,使得踝气囊位于踝的内侧和外侧(图b)。

步骤 3: 脚直立于地板上, 调整足弓气囊 4, 使其位于足弓底下,再系上绑带#1(图 c)。

注意 2: 绑带不要过紧,请 根据需要调整绑带长度

保养与维护

产品可以用中性洗涤剂和 30℃水手洗,并自然风干。切勿放入干衣机或使用其他热源进行干燥。盐水、沙子、污垢等元素会造成伤害。暴露于这些条件后,用清水彻底冲洗,毛巾擦干或风干(不要机器干燥)。如需洗涤剂请使用温和洗涤剂,切勿使用柔软剂和漂白剂。


1) Product features and storage conditions

【Product features 】 The product is simple, and the self-pressure type double-air bag linkage design is adopted, and is comfortable and air-permeable.

【Storage conditions】 This product should be stored in a room with no more than 80% relative humidity, no corrosive gas and good ventilation to avoid high temperature

Note1: please put on socks before wearing Ankle Brace.

STEP 1:Loosen the strap#1, put the foot into the holder facing the bandage (Fig

STEP 2:Adjust the airbag #2 and #3 of the retainer so that the airbag is located medial and lateral to the ankle (Fig b)

STEP 3: Stand your feet on the floor, adjust the arch air bag 4 so that it is under the arch, and then tie the strap#1 (Fig c).

Note 2: the straps should not be too tight. Please adjust the length of the strap as needed

Maintenance:

Lining can use neutral detergent and 30 °C water washed by hand, and natural dry. Do not use clothes dryer or other heat source for drying. Salt water, sand, dirt and other elements can cause damage. After exposure to these conditions, rinse thoroughly with water, dry with a towel or air dry (do not machine dry). If you need detergent, please use mild detergent, do not use softener and bleach.
