由尼龙、海绵、塑胶等材料制成。穿戴于肢体体表，通过限制肢体活动，达到保持肢体稳定的目的。不具备矫形功能。无源产品。

1.5 工作原理

产品采用轻量化的设计，使用方便，佩戴舒适。所述产品是一种功能性的踝关节固定器，可以稳定上踝关节，并有助于防止足内翻和足外翻。符合人体解剖学形状的坚固外壳为患者提供牢固而舒适的贴合体验。内置的软泡棉垫和特殊设计的柔性边有助于防止压痛点和为患者提供舒适的穿戴感。可调节的绑带便于患者的轻松使用。此产品结构纤细可在各种鞋子中穿戴。

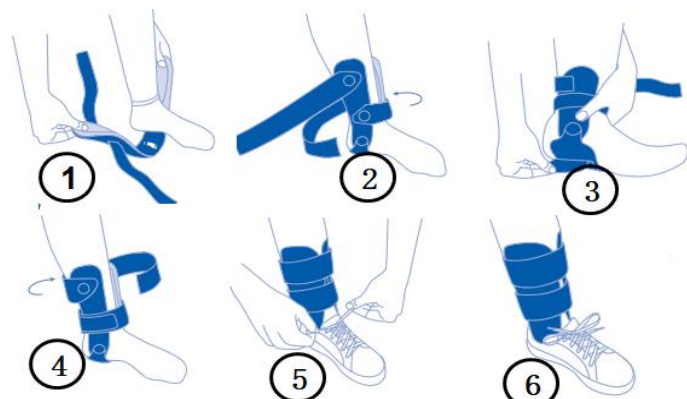
2.1 产品特点及贮存条件

【贮存条件】本产品应贮存在相对湿度不大于 80%、无腐蚀性气体和通风良好的室内，避免高温

2.2 使用操作

【使用方法】使用说明



注意：为了最佳的穿着舒适度，建议穿着袜子穿戴。

步骤 1：将脚放在两个外壳之间的足跟护带上（图 1）。

步骤 2：固定好下部的绑带（图 2）。

步骤 3：打开足跟护带并调整到舒适的宽度（图 3）。

步骤 4：将上部绑带固定住（图 4）。

步骤 5：穿上鞋在正常步态下得到最佳支撑（图 5 & 6）。

保养与维护

产品可以用中性洗涤剂和 30℃ 水手洗，并自然风干。

切勿放入干衣机或使用其他热源进行干燥。盐水、沙子、污垢等元素会造成伤害。暴露于这些条件后，用清水彻底冲洗，毛巾擦干或风干（不要机器干燥）。如需洗涤剂请使用温和洗涤剂，切勿使用柔软剂和漂白剂。所有部件在再次使用前必须风干并完全干燥。

The product is mainly composed of polymer shell, sponge pad, straps, rivets, magic stickers and so on.

#### 5)Operating principle

The product adopts lightweight design, easy to use and comfortable to wear. The product is a functional ankle protector, which can stabilize the upper ankle joint and help prevent foot varus and foot valgus. A solid shell in accordance with the anatomical shape of the human body provides a solid and comfortable fitting experience for patients. The built-in soft-foam pad and a specially designed flexible edge help to prevent pain points and provide a comfortable feel to the patient. Adjustable straps are easy for patients to use. The structure of the product is slender and can be worn in all kinds of shoes

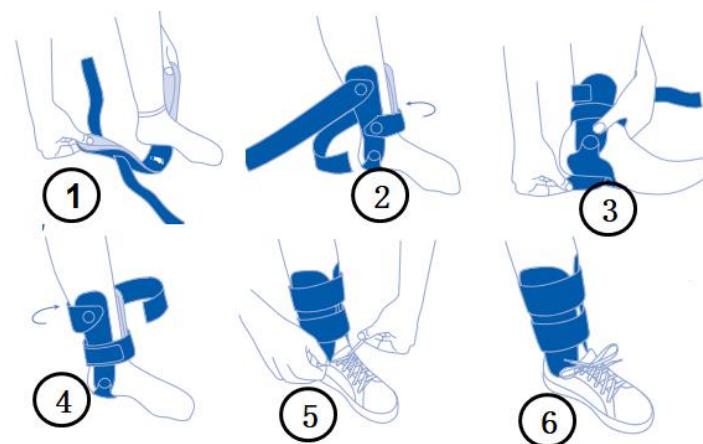
**【 Product features 】** The product is convenient to use and comfortable, has good air permeability, high strength, good fixation and can be cleaned.

#### APPLICATION INSTRUCTIONS



**Note: for the best wearing comfort, it is recommended to wear socks and then wear protective gear.**

**STEP 1:** place the foot on the heel strap between the two shells (Fig 1)

**STEP 2:** fix the lower strap (Fig2).

**STEP 3:** open the heel strap and adjust to a comfortable width(Fig 3)

**STEP 4:** fix the upper strap (Fig4).

**STEP 5:** put on your shoes and get the best support at normal gait (Fig 5 & 6).

#### Maintenance:

Lining can use neutral detergent and 30 °C water washed by hand, and natural dry. Do not use clothes dryer or other heat source for drying. Salt water, sand, dirt and other elements can cause damage. After exposure to these conditions, rinse thoroughly with water, dry with a towel or air dry (do not machine dry).If you need detergent, please use mild detergent, do not use softener and bleach.

All parts must be air-dried and completely dry before use
